Registered Charity

Epping Forest is a registered charity set up to manage the Forest under the governance of the Conservators. The City of London Corporation own Epping Forest and pay for its management from private funds as well as through earned income. There is no income through council tax and no direct charge is made to users of the Forest.

Under the Epping Forest Act 1878 and Epping Forest Bye-Laws some activities taking place within the Forest require a licence from the Conservators. By licensing activities we can better monitor what takes place in the Forest and help to ensure that activities do not clash and that users of the Forest are kept safe.

We administer a charge for some licensable activities. This is because some activities have a direct cost to administer and deal with its impact on the Forest. In all cases the income is reinvested in to the protection of the Forest.
