

# Analyst Update

- A Stakeholder review was undertaken to assess the current tools and data available within the City of London and wider engagement to ensure that the tool would be capable of being rolled out nationally to tackle VAWG.
  - Current and former members of City of London Police
  - Civilian data professionals and experts in data analysis from universities and large data companies inc. Birmingham City University, Oxford Partnerships and Microsoft.
  - Safer Business Network.
  - Senior security professionals both within the city and with national remits.
  - Police data champion for Hertfordshire police.
- Leveraged relationships to develop specification for tool in partnership with Iain Rice AI and Data Science Professor at BCU and Alison Jordan owner of Oxford Partnership along with key input other data professionals.
- Data sets are extremely expensive to acquire:
  - Full database of all licenced establishment in the UK including visiting demographics, ownership of sites, brands etc (gives full picture of the trading style of the sites)
  - Anonymised Google footfall data to show footfall over time.
  - Google data to identify routes through the city.
  - Also has crime data overlayed from open access information.
- Project initiated and twice weekly project review meeting for circa 3 months to develop MVP and then subsequently to perfect content, data access and deliver mechanism for the tool.
- Analytics tool looks at crime /footfall/licence venues and has been developed using Oxford Partnership IP data sets and has identified "hot spot" areas within the city for VAWG.
- Leveraged relationships with Alison Jordan and Iain Rice to facilitate tool being made available free of charge to SBN and City of London Police for trial period.
- The analytics tool is in use at Safer Business Network and has been used in conjunction with the P-VAWG survey results to direct the work of the researcher and to target the acquisition of Safe Havens and Ask for Angela sites in "hot spot" locations. (see new safe haven and Ask For Angela data)
- The analytics tool is a cloud-based tool which is now ready to be deployed to the City of London Police.
- The tool has multiple applications which could be used in preventing VAWG and wider application in resource planning and allocation across the city.
  - Hot Spot analysis for the City of London Police
  - Resource planning for the City of London Police especially with hourly movement of people functionality.
  - Resource planning for other departments in the Corporation such as street cleaning and refuse due to accurate mapping of people movement with time and location.
  - Can be used in conjunction with Police Intelligence to locate CCTV and lighting.



# Prevent VAWG Survey

- Stakeholder consultation process was undertaken with key stakeholders.
  - Survey Analyst at City of London Police
  - CoLCPA ,CSSC, Security Institute and several security based businesses in the city.
  - Business community meeting to engage businesses into survey.
  - Councillors in City of London.
- Comprehensive analysis of existing VAWG surveys results and methodology.
- Mindset Associates donated the cloud-based survey tool free of charge to CoLCPA for the survey.
- Survey developed in conjunction with survey professionals.
- Launch and implement survey and distributed to city.
- Weekly comms to stakeholder to engage city population to fill out the survey and calls to stakeholders to get distribution to key populations (university, businesses as well as via security companies)
- Analysis of data developed in conjunction with data scientists to pull out statistically relevant findings. This process took place over several weeks and statistical analysis tools were used to dig in the data.
- Infographic highlighting key findings.
- Distribution of finding of survey to all relevant stakeholders including via LinkedIn to general-public.





















### Taxi Marshal Scheme



- Developed analytics on Taxi Marshal scheme in conjunction with project owner.
- Free of charge to CoLCPA for the Taxi Marshal survey.
- Implemented, and provide analysis on Taxi Marshal scheme weekly to project owner and CoLCPA to amend and develop operating procedures and timings.
- Social media posts to highlight success of Taxi Marshal scheme.

#### **Snapshot of Survey Results:**

- **334** responses
- 97.5% Feel Safer because of Taxi Marshals.
- 97% Feel Taxi Marshalling is helpful in getting a taxi to their destination
- 202 verbatim responses recent examples below:
  - "Carlos went out of his way to get a very special item back to me that I left in a taxi. I am so grateful he rescued it and returned it to me"
  - "Great service!"
  - "I felt very safe as a lone pregnant woman travelling late at night."
  - "As a woman walking home on her own I believe the Marshals are extremely important. They were very kind and made me feel safe. They should get all the support they need to carry on"
  - "Amazing service. I am always afraid to get out of Liverpool Street Station. The Marshals made me feel safe"
  - "It was good to see someone marshalling the taxis. It stops the queues and helps women on their own!"
  - "Keep up the great work, as a women I really appreciate the service."








#### Strategic use of data analysis

- The data analysis has been a key component in developing the Prevent VAWG strategic plan.
  - Understanding the landscape of Prevent VAWG in the City (Survey, analytics tool and data sets) has been hugely valuable in directing the key focus for P-VAWG
    - Young people
    - Night-time economy
    - Perception of fear
    - Darkness
- A comprehensive analysis of evidence gathered by other bodies (College of Policing, NPCC, ONS and other governmental and non-governmental organisations) has illuminated what initiatives we should focus on and what is so far unproven, and we needed to gather evidence to support e.g. Taxi Marshaling where we now have qualitative and quantitative data to show the value of the scheme.
- A number of focus groups has been held a Mansion House supported by the Lady Mayoress to refine and understand our strategic communications and the outputs have fed into the next steps.
- The analysis has been used to produce the strategic plan illustrated below and to engage the P-VAWG board and wider stakeholders.

#### Summary

The purpose of this report is to update partners and the public on the City of London Reducing Re-Offending Delivery Group, which Links to the Safer City Partnership Strategic Plan 2022–2025. The work of the different agencies can be found in the action plan in the appendix.

# Main Report

#### Background

- 1. The Reducing Re-offending Delivery Group is part of the Safer City Partnership's response to Reducing reoffending to protect our communities aligning with the City's Corporate plan to contribute to a flourishing society where people are safe and feel safe.
- 2. We are working in partnership to improve the interventions we have in place against the seven pathways of reoffending.

#### **Current Position**

1. The subgroup continues to work on set objectives identified in our agreed plan alongside addressing the challenges that the unique landscape of the city presents with evidencing the reduction of offending/re-offending in the city.

#### Progress

- 2. Access to Interventions continues to be provided in Police custody aiming to tackle the drivers that can contribute to re-offending.
- 3. Due to the unique landscape of the CoL reoffending is complex, as much of this comes from those who reside outside of the city. It was noted in the last update that all partners agreed that better understanding of the individuals impacting the City was required; to be able to ensure and demonstrate that all means of monitoring, support, restriction, and disruption was being provided to Offenders.
- 4. CoL IOM provided a dataset of IOM contacts between January 2023 -September 2023 for Probation review. This data has now been cross referenced with Probation data to provide some insight to the offender journey for cases identified. Findings from this data set will now need to be discussed with the subgroup when they meet next month.

Summary of the interrogation:

- Of the 26-case identified by the Col IOM none of these offenders resided in the CoL. Hackney (10) and Wandsworth (5) had the highest numbers.
- 3 of the cases were identified as being of no fixed abode (NFA) but were managed by their last associated borough (Southwark, Lambeth and Tower Hamlets).
- Not all of the 26 cases were identified as IOM cases in their respective boroughs. (This is likely attributed to the fact that CoL has a small IOM cohort and as such CoL IOM team take an active approach to capture as many offenders impacting the city).
- Several of the cases identified were provided with referrals for Accommodation, Education, Training, and Employment, and Personal Wellbeing intervention. Levels of engagement varied across the group, and it has not yet been possible to establish a consistent reason for this. It was noted that different borough processes and approaches to intervention exist which will impact the outcomes recorded for individuals, something the subgroup continues to navigate.
- Of the 26 cases 5 have reoffended within the CoL between September 23 and August 24. The subgroup will be looking into the 5 cases to further understand these particular cases.

5. CoLP and Probation have been working together to streamline the process regarding MAPPA (Multi Agency Public Protection Arrangements) in the city and provide further assurance around the joint management of these cases.

Cases that meet the requirement for Level 2 or 3 management (not single agency management) would be discussed at Hackney & City MAPPA where all relevant agencies to the case being discussed would be invited. Cases that are managed at Level 1 (Single Agency management) will be discussed in quarterly meetings with either the Level 2 or 3 MAPPA Probation Chair, CoL Police representative, and the Case manager. Additional partners will be invited to the meetings. Whilst it is acknowledged that there has been some delay in agreeing the dates of these meetings this has been due to current operational pressures however, the first meeting will be scheduled when the subgroup next meets.

6. Probation and CoLP continue to work on adopting an agreed process for daily intel sharing. This will allow us a partnership to demonstrate our response to overnight arrests. Some initial data has been shared and it is hoped that moving forward we will have the process and resources in place to improve our current information sharing which will have a direct impact on positive outcomes towards reducing risk of further offending in the city.

#### **Future Activity**

- 7. In addition to actively working on our overall objectives identified in our plan. The subgroup will now focus on exploring the findings from the shared data to further understand and evidence the impact that the partnership is having on reoffending. It will also allow us to identify any gaps that we need to address.
- 8. Whilst it is noted that different boroughs have different processes and approaches there will be some outcomes which will allow us to identify where we may need to influence other boroughs through working in partnership to try and achieve better outcomes.
