The draft City Plan fails to protect one of the most important religious buildings in the world, Bevis Marks. It has to prevent large scale and tall new developments in its vicinity. In general too, there should be no more such large and tall new buildings in the City, its history and atmosphere risk being ruined. Para HE1(6) should mandate the preservation of conservation areas. Para HE1(8) should specify that the whole setting of the synagogue and its immediate surrounds should be protected. In para S13 the Monument is protected and the synagogue should be given the same protection. Policy S12(5) - tall buildings must give way to the preservation of heritage assets; it is not enough to take them into consideration. Tall Buildings Area and related height contours in Figs 14 and 15 must exclude the synagogue and its setting. The presumption against tall buildings in conservation areas which is currently in Policy CS14 of the City Plan should be included in the new Plan.

Over time the protection given to the Synagogue has become insufficient and the draft new City Plan would remove it altogether if not modified, with very damaging consequences that would be felt beyond the UK. The examing inspector needs to have this fully explained by interested parties and the objectors who have the preservation of the heritage and beauty of the city at heart.
