The Common Council of the City of London, after consulting the Commissioner of Police for the City of London, in exercise of the powers conferred by sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and section 8 of, and Part I of Schedule 5 to, the Local Government Act 1985(b), and of all other powers thereunto enabling hereby make the following Order:-

- 1. This Order may be cited as The City of London (Waiting and Loading Restriction) (Amendment No. *) Order 2024 and shall come into operation on *****.
- 2. In this Order, "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument, having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, reenacted by or as having effect by of any subsequent enactment.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of London (Waiting and Loading Restriction) (Consolidation No. 2) Order 2021(c) shall have effect as though:-
 - (a) for the item in Schedule 1 to that Order numbered 295 there were substituted with the item similarly numbered and set out in Schedule 1 to this Order; and
 - (b) for the item in Schedule 2 to that Order numbered 128 there were substituted with the item similarly numbered and set out in Schedule 2 to this Order.
