The City of London (Waiting and Loading Restriction) (Amendment No. *) Order 2025

The Common Council of the City of London, after consulting the Commissioner of Police for the City of London, in exercise of the powers conferred by sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and section 8 of, and Part I of Schedule 5 to, the Local Government Act 1985(b), and of all other powers thereunto enabling hereby make the following Order:-

1. This Order may be cited as The City of London (Waiting and Loading Restriction) (Amendment No. *) Order 2024 and shall come into operation on *****.
2. In this Order, “enactment” means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument, having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by of any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of London (Waiting and Loading Restriction) (Consolidation No. 2) Order 2021(c) shall have effect as though:-
 - (a) for the items in Schedule 1 to that Order numbered 44, 188, 215, 260, 267 and 292 there were substituted the items similarly numbered and set out in Schedule 1 to this Order; and
 - (b) the provisions of that Order shall apply to the items in Schedule 2 to this Order as if those items were in Schedule 2 to that Order.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order further amends The City of London (Waiting and Loading Restriction) (Consolidation No. 2) Order 2021, in the City of London, in:-

- (a) **Black Friars Lane** to introduce ‘at any time’ waiting and ‘at any time’ loading restrictions on both sides at its junction with Ludgate Broadway;
- (b) **Carter Lane** to introduce ‘at any time’ loading restrictions on both sides at its junction with Ludgate Broadway;
- (c) **Knightrider Court** to introduce ‘at any time’ waiting and ‘at any time’ loading restrictions on the south and east side from its junction with Knightrider Street;
- (d) **Ludgate Broadway** to introduce ‘at any time’ waiting and ‘at any time’ loading restrictions on both sides, except for a 13.5 metres section on the east side outside No.11 Ludgate Broadway;
- (e) **Pageantmaster Court** to introduce ‘at any time’ waiting and ‘at any time’ loading restrictions on both sides at its junction with Pilgrim Street
- (f) **Pilgrim Street** to introduce ‘at any time’ waiting and ‘at any time’ loading restrictions on both sides, at its junctions with Pageantmaster Court and Ludgate Broadway;
- (g) **St. Andrews Hill (northern arm)** to introduce ‘at any time’ waiting restrictions on the east side at the southern end of the arm.

Note:

Restricted Hours in Schedule 1 means:

A – At Any Time

B – Between 7 a.m. and 7 p.m. on Mondays to Fridays and between 7 a.m. and 11 a.m. on Saturdays, any such day not being Christmas Day, Good Friday or a Bank Holiday

Restricted Hours in Schedule 2 means:

1 – At Any Time
