The Common Council of the City of London, after consulting the Commissioner of Police for the City of London, in exercise of the powers conferred by sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and section 8 of, and Part I of Schedule 5 to, the Local Government Act 1985(b), and of all other powers thereunto enabling hereby make the following Order:-

- 1. This Order may be cited as The City of London (Waiting and Loading Restriction) (Amendment No. *) Order 2024 and shall come into operation on *****.
- 2. In this Order, "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument, having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, reenacted by or as having effect by of any subsequent enactment.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of London (Waiting and Loading Restriction) (Consolidation No. 2) Order 2021 (as amended by The City of London (Waiting and Loading Restriction) (Amendment No. 10) Order 2023) (c) shall have effect as though:-
 - (a) the items in Schedule 2 to that Order numbered 2, 65, 76, 97, 103, 105 and 130 there were substituted the items similarly numbered and set out in Schedule 1 to this Order; and
 - (b) the provisions of that Order shall apply to the items in Schedule 2 to this Order as if those items were in Schedule 2 to that Order.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order further amends The City of London (Waiting and Loading Restriction) (Consolidation No. 2) Order 2021 (as amended by The City of London (Waiting and Loading Restriction) (Amendment No. 10) Order 2023), in the City of London, in:-

- (a) **Aldersgate Street** to introduce 'at any time' loading restrictions on both sides between its junctions with St Martin's Le Grand and The Rotunda;
- (b) Angel Street to:-
 - (i) introduce 'at any time' loading restrictions on the south side between King Edward Street and St Martin's Le Grand;
 - (ii) introduce 'at any time' loading restrictions on the north side, at its junction with King Edward Street for a distance of 10 metres in an easterly direction;
 - (iii) introduce 'at any time' loading restrictions on the north side from a point 42.4 metres east of the junction with King Edward Street to a point 38.7 metres west of the junction with St Martin's Le Grand;
 - (iv) introduce 'at any time' loading restrictions on the north side from the junction with St Martin's Le Grand to a point 21.9 metres west of that junction;
- (c) **Gresham Street** to replace a section of the '7am to 7pm Mon to Fri' loading restrictions on both sides east of its junction with St Martin's Le Grand with 'at any time' loading restrictions;

- (d) King Edward Street to replace all existing loading restrictions with 'at any time' loading restrictions to cover its entire length;
- (e) Montague Street to replace all existing loading restrictions with 'at any time' loading restrictions to cover its entire length;
- (f) **New Change** to extend the length of the existing 'at any time' loading restriction by 3.2 metres by in a southerly direction;
- (g) Newgate Street to replace all existing loading restrictions with 'at any time' loading restrictions from its junction with Cheapside to its junction with Warwick Lane;
- (h) St Martin's Le Grand to replace all existing loading restrictions with 'at any time' loading restrictions to cover its entire length.
